**PAYMENT DETAILS**

(1) Tuition can be paid in full at the beginning of the school year with a 5% discount applied at time of payment. Generally, tuition is not refundable, but in the case of a pre-payment for the year, circumstances may be considered and a refund may be offered.

(2) If tuition is not paid in full, it will be paid starting August 1<sup>st</sup> of each year and divided into 10 equal payments. The last payment is due May 1<sup>st</sup> of the school year.

(3) Tuition is late after the 10<sup>th</sup> day of the month. A late fee of \$10.00 will be applied to that tuition payment on the 11<sup>th</sup> day of the month. If the payment is still not received by the 1<sup>st</sup> day of the following month, the student may not be permitted to attend school until funds have been restored.

(4) If a student enters the school year late, their tuition payment will be pro-rated on a quarterly basis according to the current school year calendar. Students who enter during 1<sup>st</sup> quarter will owe the full year's tuition, those who enter during 2<sup>nd</sup> quarter will owe 75% of the full year's tuition, those who enter during 3<sup>rd</sup> quarter will owe 50% of the full year's tuition, and those who enter during 4<sup>th</sup> quarter will owe 25% of the full year's tuition.
